

ADVERTISEMENT FOR BIDS

DOWNERS GROVE SANITARY DISTRICT OF DUPAGE COUNTY, ILLINOIS

1. Time and Place of Opening Bids. Sealed proposals for the construction of the Outfall Sewer Sag Repair for the Downers Grove Sanitary District of DuPage County, Illinois will be received at the Administration Center at 2710 Curtiss Street, Downers Grove, Illinois 60515 until 10:00 A.M., Wednesday, June 10, 2020, and at that time will be publicly opened and unit price total read aloud. Should the District office be closed, proposals shall be placed in the drop box outside the office. In addition, should the District office be closed to the public at the time of bid opening, the bid opening will either be broadcast live on the internet or recorded and made available to bidders.

2. Description of Work. The proposed construction consists of installation of approximately 250 lineal feet of 42-inch sanitary sewer, including connection to existing manhole and existing sewer, surface restoration, and other miscellaneous items of work.

3. Information for Bidders. Copies of the Bidding Documents may be obtained from QuestCDN Construction Data Network, <http://bit.ly/23V1i2M>, upon a non-refundable payment of \$15.00 per set. Only pre-qualified Bidders may purchase Bidding Documents and submit Bids. A free copy of AGC Document No. 220, Construction Contractor's Qualifications Statement for Engineered Construction, may be obtained at the District Office or electronically by contacting Megan Fox from Baxter & Woodman, Inc., Consulting Engineers at 815.444.3355 or mfox@baxterwoodman.com.

The completed and signed Construction Contractor's Qualifications Statements will be reviewed and approved on a rolling basis and must be submitted to Megan MacQuilkin via mmacquilkin@dgsd.org no later than 3:00 P.M. on Thursday, June 4, 2020. After evaluating each Construction Contractor's Qualifications Statement, the Downers Grove Sanitary District will determine and contact qualified bidders.

The password required for access to the Bidding Documents at Quest CDN Construction Data Network may be obtained after the Owner has approved the required pre-qualification statement.

Not less than the prevailing rate of wages as determined by the Department of Labor or determined by the court on review shall be paid to all laborers, workmen and mechanics performing work under this contract.

The Downers Grove Sanitary District is exempt from the Illinois State, municipal or county Retailers Occupation Tax, Service Occupation Tax, Use Tax, and Service Use Tax as described in Illinois Compiled Statute Chapter 35. Bid prices shall not include the cost of such taxes.

All Bids must be accompanied by a Bidder's bond, certified check, bank cashier's check or bank draft payable to the Downers Grove Sanitary District for ten percent (10%) of the total amount of the Bid as provided in the Bidder Instructions.

A **Mandatory** Pre-Bid Conference of all prospective Bidders and/or their representatives will be held at the project site on Thursday, May 28, 2020 at 9:00 A.M. Bidders are **required** to attend and participate in the conference, and in order to do so, prospective bidders **must first contact** Alex Bielawa, Staff Engineer, at abielawa@dgsd.org in order to notify the District of their intention to attend. Alex Bielawa will communicate to such prospective bidders additional District rules for the Pre-Bid Conference in order to comply with current social distancing requirements.

4. Rejection of Bids. The Board of Trustees reserves the right to reject any or all Bids and to waive technicalities. Unless the Bids are rejected for good cause, award of contract shall be made to the lowest responsible and responsive Bidder.
